

3.7 LSUS will monitor the quality of the curriculum implementation, program delivery and make necessary course correction to ensure that the program outcomes are in line with industry expectations.

4. Responsibilities of RBM

4.1 The RBM shall make available dedicated classrooms for conduct of training programs along with projector facilities conducting the Life Skills Training sessions.

4.2 RBM will be responsible for spreading awareness, enrolling students and helping form batches and scheduling classes in collaboration with program coordinators and trainers from LSUS.



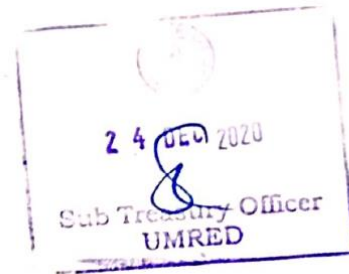

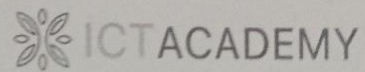

This Memorandum of Understanding is entered into at Chennai on this 26th day of July month in the year Two Thousand Twenty-Four (2024).

Randhirsingh Bhadoriya Mahavidyalaya, Umred represented by its Director / Principal/ Registrar being the beneficiary of this MoU having its principal of business at Randhirsingh Bhadoriya Mahavidyalaya, Umred, duly represented (hereinafter referred to as Randhirsingh Bhadoriya Mahavidyalaya, Umred, which expression shall, wherever the context so permits mean and include successors and assigns.)

WHEREAS

ICT Academy is inter alia established as a society with Consortium of Government of India, Government of Tamil Nadu and Industry. It is the pioneering venture under the Public-Private-Partnership (PPP) model that endeavors to train the higher education teachers of the country in the areas of Information and Communication Technology (ICT) thereby making their students to be industry-ready.

The core objective of ICT Academy is to train the Students and faculty members of Engineering, Arts, Commerce and Science Colleges, Polytechnics and IT across the country. ICT Academy will develop and maintain a world class ICT industry related curriculum and content in close association with Academia and industry, which would be made available to Students and faculty members throughout the country through online portal. Industry experts would train the learned faculty to keep them abreast of the industry demands and thereby the students. The Academy shall have core team faculty members to conduct the training. This core team would be supported by faculty deputed from Industry as well drawn from the educational Institutions.

The ICT Academy is led by a Governing body chaired by The chairman of the board Mr. Dheeraj Kumar IAS Additional Chief Secretary - Information Technology and Digital Services Department Government of Tamil Nadu, Mr. Arun Roy IAS Secretary - Industries Department Government of Tamil Nadu, Mr. Josh Foulger-Country Head & Managing Director, Foxconn International Holding (FIH), India, A Karthik IAS Principal Secretary - Higher Education Department Government of Tamil Nadu Mr. Praveen P Nair IAS Managing Director Electronics Corporation of Tamil Nadu, V. Balakrishnan – Chairman, Micro Graam, Lakshmi Narayanan Emeritus Vice Cognizant, Krish Ganesan - Vice President - HR & Global Head Recruitment, Tata Consultancy Services.

The ICT Academy is also led by an advisory board consisting of Kumar Jayant IAS, Additional Chief

Secretary – Labour & Skill Development, Government of Tamil Nadu, Sunita Sanghi IES, Former Consulting Advisor - Ministry of Skill Development & Entrepreneurship, Government of India. This initiative aims to meet the skill requirements of the industry and generate more employment in the country especially in tier 2/3 cities.

In the year 2010, this college was founded with the aim of providing skill based, job oriented courses to rural students which they otherwise do not have access to in their areas. They follow the syllabus prescribed by RTMNU and work very hard to achieve good results in the same. Every year their college results stand topmost in the rural sector. Not just this, our staff undertakes several co-curricular activities in the form of camps and personality development seminars and workshops from time to time. Their staff undergoes training to keep up with the latest information on their subjects.

ICT Academy has approached Randhirsingh Bhadoriya Mahavidyalaya, Umred Institution to be the member of ICT Academy to offer various training and services to the College faculties and its students.

ICT Academy is also keen on collaborating with Randhirsingh Bhadoriya Mahavidyalaya, Umred and is agreeable to enter into this MoU with them Vellore as per the terms and conditions set out hereunder:

Now this MoU witness as under:

1 Scope of the MoU

- 1.1 The **Randhirsingh Bhadoriya Mahavidyalaya, Umred** hereby agrees to become the member of ICT Academy
- 1.2 ICT Academy and **Randhirsingh Bhadoriya Mahavidyalaya, Umred** would collaborate to offer services to the faculty members of the College and its Students.

2 Role of ICT Academy

- 2.1 ICT Academy shall conduct industry relevant training programs in the domain of ICT, for which the faculty members of the college shall be invited.
- 2.2 ICT Academy shall make its content accessible through a web portal for the teachers of the Institutions.
- 2.3 ICT Academy shall provide various domain specific training programs, either drawn from the

- industry, by ICT Academy experts and approved by ICT Academy Board of Studies.
- 2.4 ICT Academy will facilitate partner programs for the Institute.
 - 2.5 ICT Academy shall be providing free CSR Trainings to the Students
 - 2.6 ICT Academy shall provide free online access to ICTACT Research Journals
 - 2.7 ICT Academy shall provide expert advice as a Member of the Board of Studies/Academic Council and improve the quality of the curriculum as per the industry requirements.
 - 2.8 The ICT Academy shall notify about the programs to the faculty members from nearby colleges in the region and assist in the active participation of faculty members for free
 - 2.9 ICT Academy shall invite the teachers to submit research papers for publishing in the ICTACT journals (soft copy will be for free)

3 Role of Randhirsingh Bhadoriya Mahavidyalaya, Umred

- 3.1 The Randhirsingh Bhadoriya Mahavidyalaya, Umred shall identify and depute the Nodal Officer as single point of contact (SPOC) for ICT Academy activities at the institution.
- 3.2 Randhirsingh Bhadoriya Mahavidyalaya, Umred shall notify about the programs of ICT Academy to its affiliated Institutions and assist in the active participation of teachers.
- 3.3 The Randhirsingh Bhadoriya Mahavidyalaya, Umred shall provide the following infrastructure and support, at its campus on availability basis for the programs to be conducted by ICT Academy such as
 - a. Computer Lab infrastructure with min.50 seat capacity.
 - b. LCD/LED projector & screen, White board, Marker and other AV equipment.
 - c. Conference Hall / Seminar Hall / Auditorium
- 3.4 The Randhirsingh Bhadoriya Mahavidyalaya, Umred hereby undertakes that it shall not utilize the contents, training materials, and such other information provided hereunder beyond the scope of this MoU and shall not share information with any third party or render services utilizing the materials, contents, training materials to third parties without the consent of ICT Academy.

4 Other Terms.

- 4.1 Both the parties shall explore & jointly develop new courses for the teachers from time of time, the terms for the same will be discussed as and when required and mutually agree upon the terms and the commercials in writing.
- 4.2 Both parties shall explore to work on specific ICT related research areas as per the industry

requirements and agreed upon by both the parties.

5 Operations of this MoU

- 5.1 Upon execution of this MoU, ICT Academy shall communicate to the **Randhirsingh Bhadoriya Mahavidyalaya, Umred** the training schedules. Thereupon, the Parties shall mutually discuss and agree on the operational terms based on which ICT Academy would offer its various other services.

6 Validity of this MoU

- 6.1 The validity of this MoU would be for **One years** from the date of signing. The MoU may be renewed on completion of One years on such terms mutually agreed to between the Parties.
- 6.2 The Parties shall enter into firm binding agreements on the areas which are not covered under this MoU. Upon the execution of such agreements, this MoU may be terminated. Both parties shall have right to terminate this MoU if any of the party does not comply with its obligations under this MoU by issuing 30 days prior notice.

7 Confidentiality

- 7.1 The Parties shall treat all information, documents, contents and materials pertaining to ICT Academy or **Randhirsingh Bhadoriya Mahavidyalaya, Umred** provided under this MoU as confidential.
- 7.2 ICT Academy or **Randhirsingh Bhadoriya Mahavidyalaya, Umred** shall not disclose any aspect of any confidential information to any third party in any manner whatsoever other than in the normal course of agreed terms under this MoU.
- 7.3 The confidentiality of information shall survive the termination of this Agreement.
- 7.4 Upon the terminating of this MoU, **Randhirsingh Bhadoriya Mahavidyalaya, Umred** shall return all the contents, training materials and such other information provided by ICT Academy under this MoU duly without any undue delay and in cases where such information is not capable of being returned destroys the same and provides a certificate that to ICT Academy.

8 Intellectual Property



8.1 All the intellectual property rights with respect to the programs, contents provided by ICT Academy shall vest with ICT Academy and upon the termination of this Agreement by efflux of time or such other earlier termination, the **Randhirsingh Bhadoriya Mahavidyalaya, Umredshall** not have the right to use programs, contents, and such other training materials installed under this MoU and return the same to ICT Academy. The **Randhirsingh Bhadoriya Mahavidyalaya, Umredshall** not infringe the intellectual property rights of ICT Academy and shall duly intimate of any such infringement by any third parties.

9 Notices

9.1 All notices regarding this Agreement shall be delivered by personal delivery or by certified or registered mail, postage prepaid, at the addresses as either of them may so provide by notice given to the other in the same manner. Any such notices shall be deemed received when actually delivered if by personal delivery, or 3 days delivered to an overnight or express mail facility, if delivered through post.

10 Governing Law

This MoU is made under and shall be governed by and construed under the laws of the Republic of India under the jurisdiction of the courts at Chennai.

11 Arbitration

In the event any of any claim, controversy, dispute or difference between Parties, arising out of or in connection with or in relation to this Agreement, either Party will be entitled refer the same to arbitration in accordance with the rules of arbitration of the Arbitration and Conciliation Act 1996.

There shall be three arbitrators, one to be appointed by ICT Academy, the other to be appointed by the Institution and the third to be appointed by the two arbitrators appointed by the Parties. The award of the arbitrators shall be final and binding on the Parties. The Arbitration proceedings shall be held at Chennai.







Obligations

1. To maintain the validity of this MoU, the college agrees to:
2. 1. **Career Sansad:** Form a "Career Sansad" committee of at least 7 to 9 members.
3. 2. Organize at least one college-level program (e.g., Financial Literacy, Vidyarthi Sanvad etc).
4. 3. Ensure participation of a minimum of 10 students in at least one free value-added course per semester.
5. 4. **FDP:** Ensure participation of at least two teachers in Career Katta FDPs.
6. 5. **Workshop:** Ensure attendance of at least one coordinator or Principal at a Taluka/District/State level Career Katta workshop annually.
8. 6. **Magazine subscription:**
9. At least 1 subscription of Career Katta magazine is mandatory.
10. 7. **Annual Performance Review:** Each year, Career Katta will conduct a review based on the mandatory activities carried out by the college under this MoU. This review will assess the effectiveness and consistency of the college's participation in the Career Katta initiatives.
11. 8. **Continuation Certificate:** Based on the performance review, a *Continuation Certificate* with a performance rating will be issued to the college. Possession of a valid Continuation Certificate is **mandatory for each academic year** to maintain active participation in the Career Katta program.
